This legislative session in New Hampshire, NAIFA-NH has been successful in:

- *Again heading off efforts to create a government sponsored retirement program to compete with 401(k) plans.*
- *Preventing efforts to limit your ability to advise clients on Social Security benefits as part of retirement planning.*
- *Meeting with the Department of Insurance and Securities Division to voice our concerns on excessive regulation on our industry.*



Our ability to sell the value of what we do to legislators is critical to our success. No other professional association in our industry has our impact in this area.

Each year we host a Legislative Reception to allow our NH legislators to meet the fine professionals in our industry. It is a great opportunity for them to get to know you and the work you do for your clients – the citizens of NH. Our one goal again this year is to tell these legislators the importance of a professional advisor to the people we serve. Our clients rely on us to make critical financial decisions and we add value to the NH economy.

Again this session we have bills that impact all areas of our industry – life, health, long term care, annuities and securities. NAIFA-NH is a recognized voice in our industry. The work of our lobbyist, Bianco Professional Association, has enhanced our stature. So too have our Legislative Receptions. Our reception is now an annual event and this year marks our 14th. Last year about 200 legislators attended.
